Vendor Members will have the benefit of designating themselves as American Grown supporters with the use of the vendor logo (shown below) on their website, emails, banners and other promotional materials. This logo is restricted and cannot be used physically on the product or sleeves. Vendors may distinguish American Grown products on listings or catalogues with the heart symbol provided upon membership approval. Other applications considered on a case-by-case basis.
